Manuscripts. Please submit three copies of all article manuscripts. We encourage all writers to submit work on computer disk (MS Word 97 preferred). The name of the author and author's affiliation should appear on a cover sheet together with the title of the article. All reference, or any means of identifying the author should be removed from the article.

Contributions should be submitted on A4 paper, using one side of the page and double spacing. For general guidance on style, please follow the Style Manual for authors, editors and printers, AGPS, Canberra, 1994.

Reference. Use endnotes which should be numbered consecutively and gathered together at the end of the article. The first reference to a book shows the initial and surname of the author, the published title of the book (italicised), the publisher, the city of publication and the year of publication, together with the page reference if appropriate: G.S. Reid and

M. Forrest, *Australia's Commonwealth Parliament 1901–1988. Ten Perspectives*, Melbourne University Press, Carlton, 1989, pp. 34–37. A chapter in a book that is part of an edited collection needs the details of the author as well as the editor(s): R. Smith, 'Parliament' in J. Brett, J. Gillespie and M. Goot (eds), *Developments in Australian Politics*, Macmillan, Melbourne, 1994, p. 114. A journal article requires the name of the author, the name of the article in inverted commas, the name of the journal italicised, the volume and number details, and the date: J. Squires, 'Quotas for Women: Fair Representation?' *Parliamentary Affairs*, vol. 49 no. 1, p.73. Reference to a newspaper article shows the title of the paper (italicised) and the date: *Age*, 3 February 1990.

In subsequent references use the author's name and/or *ibid.*, *op. cit.* and *loc. cit.* as appropriate. Use short titles only to avoid confusion where two or more works by the same author are cited. For further guidance on the format of endnotes please consult the editors.

The recommended length for articles is 4,000–6,000 words, though papers falling outside these guidelines will be considered. Please provide a brief biographical note and full mailing (and when possible an email) address. Allow at least three months for the process of review and consideration to be completed.
